# **Campaign Period**

01 January 2025 – 28 February 2025

#### Introduction of Organizer

- 1. Lirunex (Registration No.: 102684) is registered under the Republic of Marshall Islands law under license with Certificate No. FC00022020 (hereinafter known as the "Company"), runs **Golden Prosperity Angpow** (hereinafter known as the "Promotion").
- 2. The Promotion runs from **01 January 2025 (00:01 Server Time)** to **28 February 2025 (23:59 Server Time)**, inclusive of both dates.

## Instructions for enrolment

- 3. The Promotion enrolment must be made by submitting the Application Form.
- 4. Clients need to ensure all the information submitted for enrolment is true and correct.

## **Promotion Criteria**

- 5. The following account types are **eligible** to participate in this Promotion (markups available):
  - a. LX-Standard
  - b. LX-Prime
  - c. Islamic-Standard
  - d. Islamic-Prime
  - e. Standard Plus Swap Free
- 6. All trading account(s) must be created from the account of the Company portal known as the Company Traders Room.
